- ❖ If over 50 sheep in a group is ID (lowest to highest ear tag) sort required.
- ❖ Is a Sire Summary required? if info is not available on the day please let the scanner know that it will be sent later.
- ❖ The scanners would appreciate someone to be available to write down the figures.
